NOTE 1: PART NUMBERING SCHEME:

CRLP(X)37L(XX)(XX)

1 = C14 STRUT
2 = A12 STRUT

STRUT SPAN "L"

"BLANK" = STANDARD FINISH (PG)
BA = BLACK COAT FINISH

Note 2: Product must be installed with the open side of the channel facing up. See Figure 1.

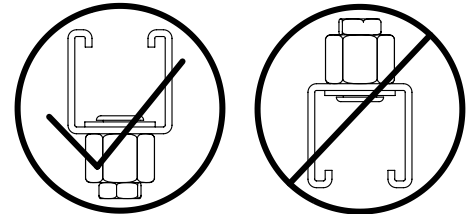
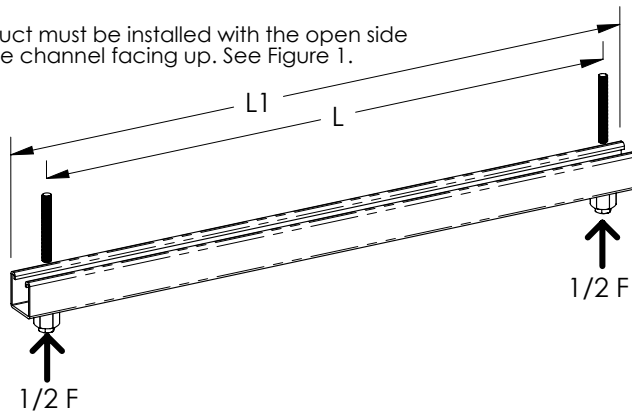
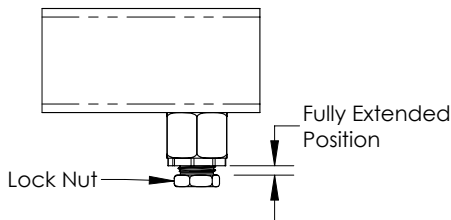


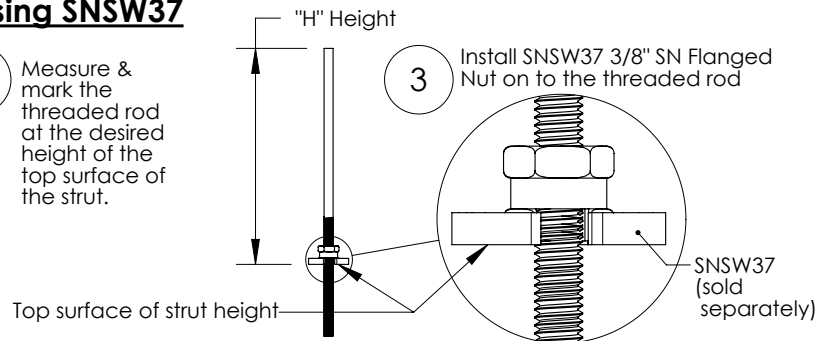

Recommended installation method using SNSW37

- 1 Rotate the lock nut counter clockwise until reaches the fully extended position



- 2 Measure & mark the threaded rod at the desired height of the top surface of the strut.

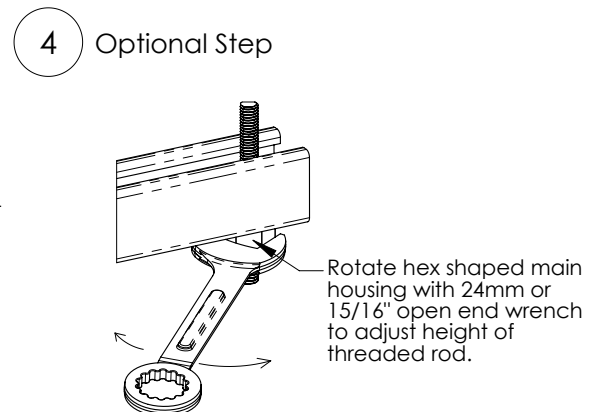
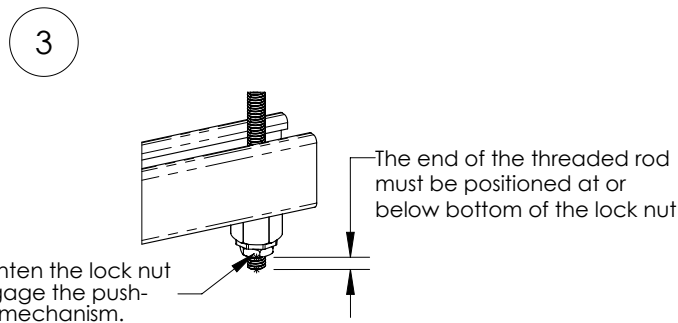
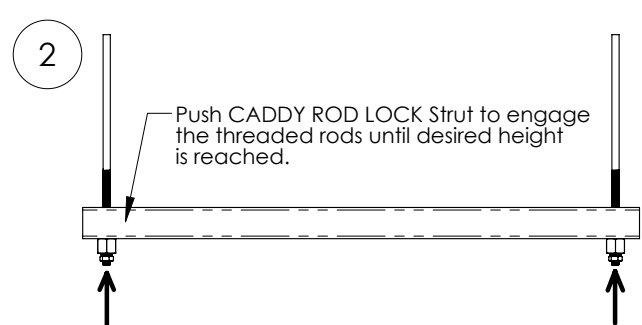
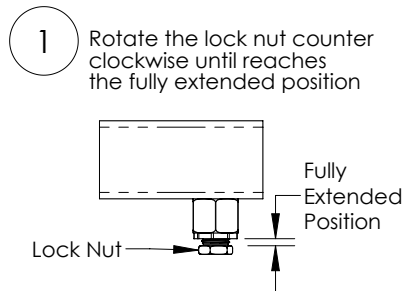


CADDY ROD LOCK Strut
