Note: Product must be installed with the open side of the channel facing up. See Figure 1.

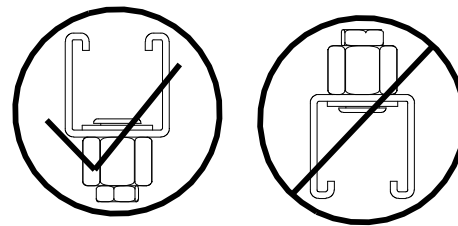
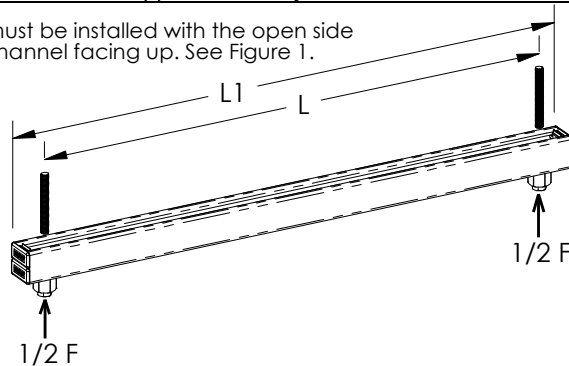
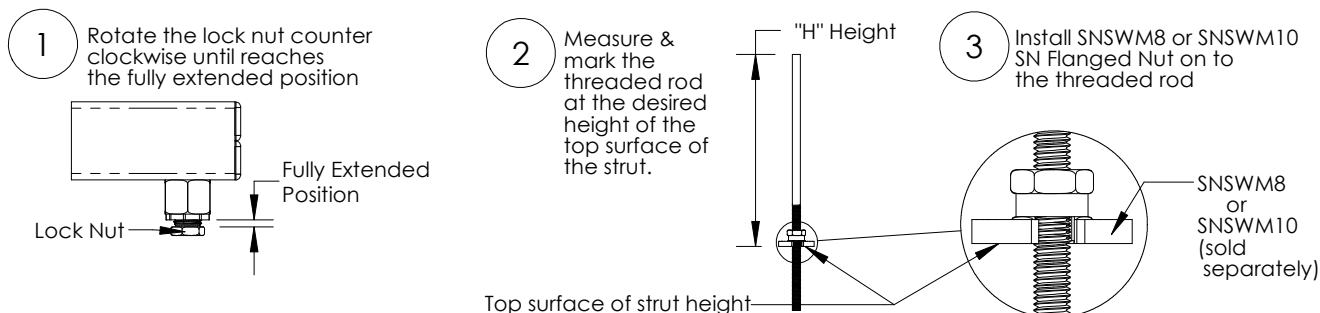

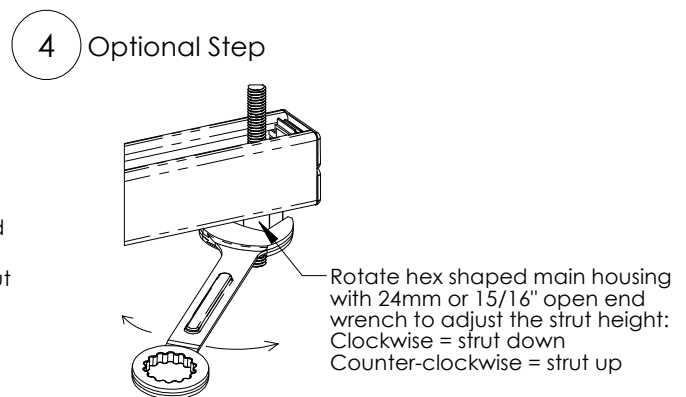
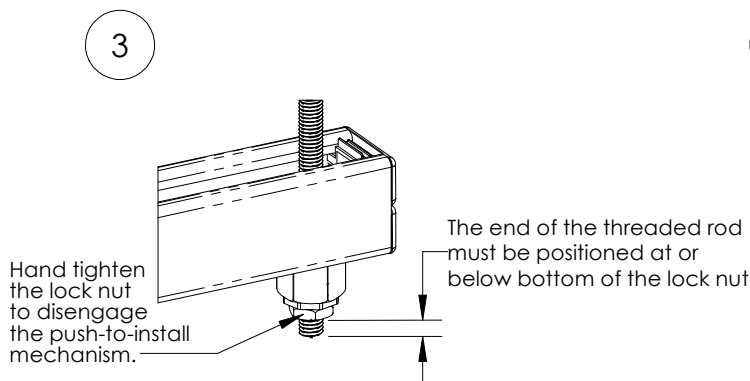
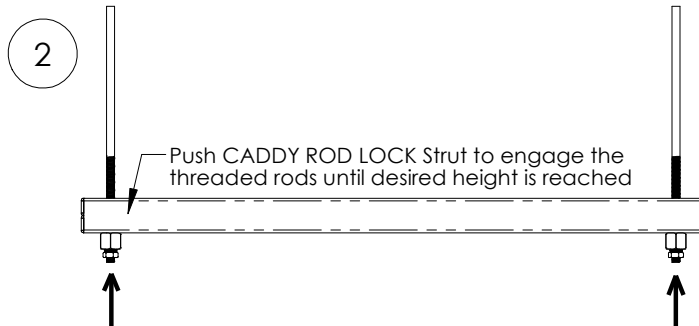
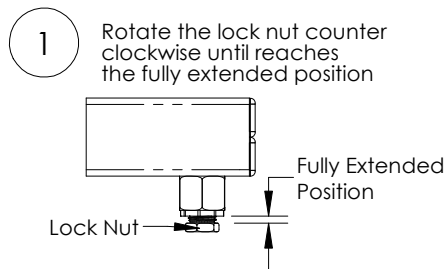


# CADDY ROD LOCK Strut
